PROPOSED ISSUE OF UNLISTED OPTIONS
UNDER THE COMPANY'S EMPLOYEE OPTION SCHEME

The Board of Directors of Beadell Resources Limited (“**Beadell**”) resolved at its Board Meeting on 27 August 2009 to reaffirm the 16 to 20% salary reductions to executives undertaken in 2008. In lieu of any cash increases in Directors fees and salaries for 2009/10, the Board resolved to seek shareholder approval for the issue of 500,000 unlisted options to each of the three Directors at an exercise price of \$0.12 each, vesting after 30 June 2010 and expiring on 30 June 2013.

The shareholders' resolution to seek approval of the options will be contained in the Notice of Annual General Meeting.

The Board also resolved to issue 800,000 unlisted options to staff, details contained in the attached Appendix 3B.
